BASE AGREEMENT SUMMER 2010

1. **ENROLLMENT AND ATTENDANCE:** I must complete and submit all enrollment forms provided by B.A.S.E. prior to my child's attendance. Children must be signed in & out upon arrival and departure.
2. **FEES AND LATE PAYMENT PENALTY:** I agree to pay Westlake Charter Registration and Monthly Fees for my child to participate in the B.A.S.E. Enrichment Program. My full June payment is due by June 16th for the month of June. Payment for July is due by July 1st, and payment for August is due by August 2nd. If full payment has not been received by the 6th of the month, *a \$25 fee will be charged.* To re-enroll, all past due money must be paid in full, including late charges. _____(initials)
3. **LATE PICK-UP PENALTY:** If I do not pick up my child by 6:00p.m. **I will be charged a late pick up fee of \$1.00 per minute per child until the child is picked up.** Payment will be due by the end of that week.

4. **ILLNESS:** My child will not attend when they are ill. If my child becomes ill during attendance, I or my emergency designee will pick up my child within 1 hour of being notified by B.A.S.E. _____(initials)
5. **DISCIPLINE:** Participation in B.A.S.E. is a choice and privilege. My child must be able to get along with others and adhere to the rules of the program. I also understand that it is necessary for parents to conduct themselves in a respectful and mature manner with all staff for the B.A.S.E. Program. I understand acceptable behavior is required to insure continued participation through the enrollment period. If disenrollment occurs during the summer, the child will not be allowed to return until the Fall B.A.S.E. Program begins in August.

6. **TERMINATE ENROLLMENT:** If I wish to disenroll my child from B.A.S.E. and terminate this agreement, a registration amendment form, which can be obtained from the B.A.S.E. Coordinator, must be submitted to the Program Coordinator by the first calendar day of the month that I wish to be disenrolled. _____(initials)
